The processing of tailing coming from artisanal mining activities consider as one of the important sector of the mining producing companies, which shares a wide space in the public mining productivity mining, the SMRC operates across General directorate for the supervision and control of the (production companies) - waste management production companies , it operates in the rationing and organization of work address artisanal mining remnants of more than 63 companies to the number of companies producing treatment and make the most of the artisanal mining waste to take advantage of productivity taking into account the environment and public safety laws. Safety & Environment:


SMRC operates across general directorate of HSE & CSR for the supervision and control of safety & environment in mining sector
